DATING OLD WELSH HOUSES

VAENOL OLD HALL,

Pentir, Near Bangor, Gwynedd

During the medieval period the Bishop of Bangor owned the land now called Vaynol Park, which with the area where the two manor houses now lie was in an area called Farchwel. (A Short History of Vaynol)

C14th ref.in Carnarfon court rolls to William de Hauton commissioning a cellar to be built at his house "at Vaynol" (might be Maenol Bangor)

(K Withersby Lench, The Origins of the Faenol Estate: A rumbustious tale, 2010.p 23)

William ap Gruffydd, of Penrhyn, Sheriff for life, co Carnarvon, 1485-1500. He brought a troop of horse to Bosworth to assist Henry VII against Richard III

He married Angharad, d of Dafydd ap Ifan ap Einion, Constable of Harlech Castle 1461; the gallant defender of the castle during the Wars of the Roses; will dated May 9 1546. (J Griffith, Pedigrees, p 186)

(son) **William Williams**, of Cochwillan, will dated 22 June 1588; proved 3 June 1589 married Lowry, d of Henry Salesbury, of Llanrhaiadr, younger son of Thomas Salesbury, of Llyweni. They had: (Pedigrees p 186)

1558 inherited by (son) **Thomas Williams**, of Vaenol who married **Jane**, d of Sir William Stanley, Kt, of Hooton, Cheshire who died 25 May 1579. (Pedigrees p 190)

1580's Wm Stanley (Thomas' father-in-law) involved in the Babington Plot. (Lench p.16) 1630 Wm Stanley died, exiled for Catholic tendencies, in the Low Countries (Lench p.16) They had:

1558 His uncle Thomas Gethin, LL.D., living 1556, left his lands in Bangor to Thomas Wynn ap William, of Vaenol. (Pedigrees p186, Lench p 15)

1558 - 1603 Queen Elizabeth

1559 Act of supremacy

Earlier 1500s: considerable amounts of land had been sold off by the Bangor bishopric from within the bishoprical home manor "Maenol Bangor". (Lench p 17)

1560's One Hugh Bangor's family's C16 hold on lands centred on the medieval townships of Aberpwll & Farchwell loosened. (Lench p.17)

Winter 1557/8 & summer 1562: Dendro dates from the hall range

1557, 1551 & 1536 Principal rafters

1161 Lower purlin

(Oxford Dendrochronology Laboratory report)

1558-62 dendrochronology dating of Old Hall range roof timbers; photo of roof timbers assigned to this date. Ref. to provincial building styles. (Lench p15, 23, 24, 25)

Maybe this was a new house, or one on a former house site, built when Thomas Williams inherited Vaynol and in preparation of his marriage to Jane Stanley.

"Lavish version of Snowdonia plan-type with projecting oriel, porch & later kitchen (?1660s) giving a busy from elevation. House has a contemporary rear parlour wing.

Service rooms were in basement under the hall.

Hall has a lateral chimney, framed ceiling, 16 panels; broad chamfered beams with curved stops with a torus. (Richard Sugett, RCAHMW)

1572 Thos. Wms recorded as having fishing rights on Menai Straits (Lench p17)

1638 1628/9 alterations carry a graffiti date of 1638. (Building recording) Maybe this was in preparation of the marriage of 1640.

1640 Marriage of Sir William to 1. Margaret Jones, d & co heiress of Griffith Jones, of Castellmarch; she died June 1647 (Pedigrees p 190, Lench pp 59-60, 66)

1697 Jan: William White was employed to oversee the estate for the executors of the will & resided at Vaenol. (Lench p86)

1697 April Forcible entry by Arthur Owen of Orielton, Pembrokshire & Bodeon, Anglesey M.P. & pretender to the heir at law of the Vaynol estate & eviction of William White. (Lench p 87-91) 1697 Dec Arthur Owen was ejected, but forcibly returned in Jan 1698.

In Feb 1698 Parliament agreed that the Wrey family had right of possession. (Lench p 91-92)

Sir William Williams had bequeathed his property & estates to **Sir Bourchier Wrey**, then of Tavistock, Devon, Baronet, for his natural life; with remainder to his son Bourchier Wrey for his natural life;

with remainder to Chichester Wrey, second son of Bourchier Wrey, for his natural life; with remainder to his Majesty King William III, his heirs etc for ever.

The Wrey family employed an agent to run the farm & estate. (Lench p 93)

1698 March, letters patent, the crown granted the manors of Vaynol & Dinorwic & all other estates to John Gore. (Pedigrees p 368)

1699 Feb 9 Deed poll: John Gore declared that the land had been granted to him in trust for John Smith, of Tedworth, Southampton, Esquire & his heirs. John Gore confirmed the same in 1720. (Pedigrees p 368)

It was left to Thomas Smith, heir of John Smith I, but he died without issue & Vaynol went to his brother, John Smith II (Speaker of the House of Commons c1703) (Pedigrees p 368) who left Vaynol to his son Capt William Smith. H.S.C. 1739; H.S.A 1769-70 Died without issue.

1725 report (Lench p93)

In his 1764 will William Smith devised the state to Thomas Assheton, son of his sister Harriet, who by Act of Parliament took the name Smith; he was Lord-Lieutenant of Carnarvonshire MP for the county for many years. (Pedigrees p 368)

1756 The Assheton Smith family came into possession of the Vaynol estate. (A Short History of Vaynol)

His son Thomas Assheton-Smith (1752-1828) married & had eight children. (Pedigrees p 368)

1774 Inherited Vaynol

1770 survey & 1777 map based on 1777 survey. (Lench p.33, 37,

93)

1793 Vaynol New Hall designed by James Defferd of Bangor (Pevsner, Gwynedd p 373) (Lench p94)

1795 NEW VILLA completed

TENANTS of the Old Hall:

1785-1792 Mr William Jones, estate under manager was tenant. (Lench p 94) 1792-c1808 William Lloyd under manager (d 1808) & Eleanor & 7 children. (Lench p 94) (Lench p 94) 1808 Their son Morgan Lloyd farmed there to 1830.

CHECK Land Tax Assessments

Thomas Assheton-Smith (1776-1858), the celebrated fox hunter, married in 1827; no children are recorded. He devised to his wife and she devised the Welsh Estates to George William Duff, eldest son of Mrs Duff, daughter of Mrs Astley, a sister of her husband. (Pedigrees p 368) He inherited in 1828. In 1831 "Tom" Smith revamped the Old Hall, re-roofing it, modernising, panelling (Lench p95-6)

New tenant: the retiring cook from the new Faenol Hall, Betty Hughes & her husband. (Lench p96) 1831 storm caused the walled garden wall to collapse (Lench p97)

Edward Roberts, wife & daughter. Wife died, & he arranged for his sister's son, Ellis James, farmer in Llanberis, take over the farm & bring up his daughter. Mr Roberts died in 1840. (Lench p 97)

1841 census: detail for the old hall

Ellis James, aged 26, + 7 agricultural labourers & 3 female servants. (Lench p97) (Lench p98-101) 1846: became secretary of the Arfon Methodist Monthly meetings. 1850 Ellis James married Jane Griffith, Edern, Penllyn.

1851 census: details

They had Catherine in 1852 and Robert in 1856. They were still there at the 1861 census. (Lench p97-98)

In 1859 George William Duff (1848-1904) assumed the name Assheton-Smith & succeeded to the estate in 1869 on attaining 21 years of age. H.S.A 1848, H.S.C. 1878. He married in 1888 & had a daughter. In 1869 Ellis James & family were asked to leave Vaynol Old Hall and move to Ty'n Llwyn, Pentir.

1871Census: details for the old hall

By 1871 A Scotsman, John Reed, a career farm steward & his wife Susannah, from Norfolk. (Lench p 101)

1881 Census: details for the old hall

By 1881 James & Caroline Kent, & Benjamin their 20 year old son lived at the Old Hall.

1891 Census details for the old hall

By 1891 William Lort, his children, butler, cook & housekeeper lived at Vaynol Old Hall. After William Lort died, his son, Thomas Lort, became the estate agent.

1901 census details for the old hall:

1905 The Lorts held a big sale of their possessions from the Old Hall before they moved. (Lench p100-104)

In 1905 his brother, **Sir Charles Garden Duff** (1851-post 1913) J.P., D. L., H.S.A. 1885; assumed the name Assheton Smith instead of Duff & succeeded to the estate. He was H.S.C. 1908; & was created a baronet 1911. He married 1. in 1876 Hon Maud Frances (1845-1893) one son; 1894 Mary Elizabeth, no children; he married in 1902 3. Sybil Mary (Pedigrees p 368) Edwardian: Old Hall garden designed by Lady Sybil Assheton Smith (Lench p56)

1910 Land Tax Assessment

1911 census details for the old hall

His son, Robert (**Robin**) **George Vivian Duff (Assheton Smith**), Lieut, 2nd Life Guards, (1876-?) in 1930 married & they had a daughter. (Pedigrees p 368)

1934 RCAHMW plan; account revised 28 November 1956, (Caernarvonshire Inventory, Vol II, monument 1387 (a), RCAHMW)

In the 1900s the Old Hall was home to a variety of farm managers & estate staff, including in the 1960s, Rachel Williams & the late David Gladstone & his family. (Lench p 105)

1952 February 22: Vaynol Old Hall listed Grade 1 by Cadw. Amended 1997 Sept 22.

His son, Sir Michael Duff Assheton Smith died in 1980.

1984 Death duties forced his son **Andrew Duff Tennant** to sell Vaynol Park at auction. The majority of the lots were bought by **Glan Gwna Estates Ltd**, a family business from Caernarfon. Mr & Mrs Jones remain the current owners. (A Short History of Vaynol)

They have extensively restored the Old Hall and it is again a family home.
